

# Building a Consolidation Structure for Eiffage Group

Eiffage, one of Europe's leading construction and concession companies, wanted a consolidation solution they could manage internally. With Prophix, Eiffage sped up their consolidation process by enabling their finance team to change parameters as needed.

## Business Challenges

The accounting department at Eiffage Group was looking for a consolidations solution they could manage internally for increased flexibility. They no longer wanted to rely on a team of consultants to configure the necessary changes. The finance team also wanted the solution to handle large volumes of data and consolidations quickly.

## Why Prophix?

- Ability to change scope throughout the year (disposals, acquisition, grouping of entities, etc.)
- Consolidation organized in transparent legal levels with 17 subgroups
- Ability to handle high data volumes (550 consolidation entries, 240 users)
